Thank you again for your feedback on the Winslow Hotel meeting. I am emailing to give you a quick update. I met with our Deputy City Manager, Ellen Schroer, and our IT Manager, Steve Miller, last Friday to test the Winslow Hotel presentation on the projector in the Council Chambers.

Ellen and Steve observed the poor clarity and we've outlined next steps to address the issue. Steve is looking into options to update the scaler and the projector system. Until the City makes any changes to the system, we will ask applicants to send their presentations ahead of time for a test run which should allow time to make adjustments if slides are difficult to see. If adjustments can't be made, they will be asked to bring printed copies of the presentation for the attendees.
