Thanks for sending the drawings. I'm one of the Wood Ave condo folks. I attended the meeting. As you heard at the meeting, many of us on the west side of the project have concerns regarding the anticipated smells and noise, but I'm also wondering whether the parking is adequate, especially given the serious parking problems we already have downtown. Please explain the parking related code requirements for a hotel that will have:

75 rooms, a spa, a restaurant and bar, concert space for 90 people, banquet hall for 200, and on-site parking for 90 cars.

Is there a requirement that the owner provide for onsite parking rather than the idea floated at the meeting that contemplates renting parking space elsewhere? My concern is that if this project is not done right the gridlock and parking problems we already see downtown will be magnified to the detriment of us all. Thanks.
