Hello Jonathan,

The information provided will satisfy verification of the two points the City requested in my October 5th, 2021 email. However, it is requested that a clarifying letter be sent to correct two issues in the letter from the applicant's attorney, Yao Bailey:

- (1) The letter references five lots owned by Bainbridge 14 LLC but only lists four lots. Please submit a clarifying letter that lists the five lots owned by Bainbridge 14 LLC and the parcel numbers for the lots. It appears that lot 27 is omitted from the letter.
- (2) Please also correct the parcel numbers in the clarifying letter. Specifically, it appears an extra "0" was added to the parcel numbers.

The parcel numbers for lots 27-31 are also incorrectly listed with an extra zero on the revised Master Land Use Application. Please submit a corrected Master Land Use Application as well.
