SEPA Conditions:

- All work shall occur outside of the wetland, as indicated on the plans. The contractor shall mark the
 wetland boundary adjacent to the project area to indicate its presence and prohibition from work
 and staging.
- 2. Any staging of vehicles and/or materials during construction activities shall occur outside of the wetlands, stream and their buffer.
- 3. The bioretention swales shall be planted with approved plantings recommended for wetlands. A plan depicting the plant type and location shall be submitted to the Planning Department prior to commencing work.
- 4. The slopes shall be reconstructed with compost-amended vegetated filter strips as indicated on the plans.
- 5. A hydrologic and hydraulic analysis is required to size the replaced culvert. In no instance shall the culvert crown overtop the road. The analysis shall be provided by the Public Works Department and reviewed and approved by the Development Engineer prior to commencing work.
- 6. Prior to commencing work, a storm drain analysis shall be provided by the Public Works Department and reviewed and approved by the Development Engineer.
- 7. Prior to commencing work, a stream diversion plan shall be provided and reviewed by Public Works for the installation of the culvert. The approved plan shall be implemented at construction.
- 8. Prior to commencing work, the Public Works department shall submit a complete drainage report and design to demonstrate compliance with BIMC 15.20 and the 2014 SWMMWW. The plan shall be reviewed and approved by the Development Engineer prior to the commencing of work.
- 9. Any required staging permits shall be acquired from the Department of Planning, if found necessary.
