We are going to revise the hotel to 87 rooms, and increase the parking count both to accommodate those added rooms, plus a few additional spaces. The overall building footprint and floor area will be either unchanged, or smaller with this revision. The building massing, and the elevations facing the street and the neighboring properties will be unchanged. The inner courtyard will have some glazing changes. I don't think these rise to a revision requiring DRB review.

Hi Bruce,

I talked with Heather this morning about the potential changes to the Winslow Hotel. If the number of rooms is increasing, we will need to re-notice the project. If we re-notice the project, we cannot go to Planning Commission on May 9 because the comment period will still be open. As we discussed, a re-notice would be a good opportunity to include a more detailed description of the proposal and provide more information on the proposed parking. Here are the timelines for re-noticing:

- Deadline for new project information: Tuesday, April 23 by 8am
- Comment period begins: Friday, April 26
- Comment period ends: Friday, May 10
- 1st Planning Commission meeting: Thursday, May 23
- (placeholder) 2nd Planning Commission meeting: Thursday, June 13
- (tentative) Hearing date: Thursday, July 11

We can keep the same Planning Commission/Hearing schedule if we re-notice on May 3 (Deadline for new project information: Tuesday, April 30 by 8am). If the design of the building changes, we should bring it back to the DRB. Their next meetings are held on May 6 and May 20.

I will continue working on the staff report and addressing public comments. I talked with Peter this morning and this is one of the next projects on his list – he anticipates reviewing it very soon.

Please let me know as soon as you've made decisions on the revisions so we can figure out next steps. Thanks!
