Hi Morgan,

The sign on the property is a Notice of Application which included a date (April 25) for the Hearing with the Hearing Examiner. We provide a tentative date on our Notice of Application signs and mailings with a note to check the City's website for any updates. We are waiting on revisions from the applicant and will not be able to make the April 25 date.

We have updated both signs to indicate that the Hearing is being rescheduled and have provided the direct link to the Hearing Examiner schedule (<http://www.bainbridgewa.gov/434/Hearing-Examiner>) so that the public can see new dates when they are available. Old and new photos are attached. We covered the April 25 date but are unable to commit to a new date until we have received the applicant's revisions. We hope to have new information posted on our webpage within the next few weeks.

Councilmember Nassar is correct, the purpose of the sign is to notify the public that an application has been received and that a hearing will be held – it does not include information about the Planning Commission dates. When scheduled, the Planning Commission's agenda will be posted in the Agenda Center and those on the listserv will receive notice of the update.

Hello,

We have a sign hammered to one of our hospital signs outside the Seattle Children's Hospital Bargain Boutique which gives information about a public meeting with incorrect dates on it. I feel the public is being deliberately deceived by the planning commission and property owner.

I contacted the city planning commission by email earlier this week to ask them to either put the correct dates/times on the signage, or confirm I could remove the sign. In fact, last week the sign had fallen off, and became damaged from rain. We fixed the sign and re-attached it, believing that it was in the best interests of our community to do so, only to find out that the info was incorrect. I received no response from the planning commission, and yet the city of Bainbridge is allowing misinformation from the city to stay posted.
