The plans submitted have been reviewed resulting in the following comments:

1. If a fire sprinkler system and/or fire alarm system is being installed, or an existing system requires modifications, plans shall be submitted to the Building Department for Fire Department review. Please be aware that while the scope of this permit will not require a fire sprinkler system to be installed, it is quite possible that future work may require such a system per BIMC requirements. Please plan accordingly.
2. Fire extinguishers are required for this occupancy. Travel distance to an extinguisher shall not exceed 75' travel distance. A minimum 5 lb., 2A 10BC rated dry chemical extinguisher is required in the dining area.
3. Premise identification (address and/or suite #'s) are required for this occupancy. It shall be of a contrasting color to the surface it is mounted to and be large enough to be clearly visible.
4. A Certificate of Occupancy inspection by the Fire Department is required. 48 hour notice required.
5. Building shall comply with all applicable requirements of the 2006 International Fire Code.
6. All Fire Department inspection requests shall be directed to Jared Moravec, Fire Marshal, at 206.842.7686.
7. Keys shall be provided for placement in the Knox Box at the time of final inspection if a Knox Box is present or is being required.
