The City of Bainbridge Island ("City") Department of Public Works received a request for Approval to Connect to the City's water and sewer systems for a tenant improvement within the building identified by Parcel Tax Account Number 272502-4-097-2000 located at 253 Winslow Way W., BLD15937TEN

A binding commitment for an unlimited reservation of water system capacity and connection to the City's water system was established through the development of the building with a full payment of water system participation fees. An analysis of the cross connection control potential hazards found that the heat pump inside the building may require in-premise backflow protection.

Based on the drawings submitted that show the existing fixture count of 54 or 2.7 equivalent residential units (ERU). 20 fixture units equal 1.0 ERUs. This tenant improvement proposes to reduce the fixture count to 48 or 2.4 ERUs. A credit will be given of 0.3 ERUs for future improvements to this building.

This letter is a **Binding Commitment** for an unlimited reservation of water and sewer system capacity and **Approval to Connect**. This commitment and approval is based upon information provided in the Water and Sewer Availability Request, Sewer Connection Analysis, and Cross Connection Control Analysis forms dated October 6, 2009, and is given with the following conditions:

- Heat pump in the existing building shall be a double walled construction with leak detection. If the heat pump is not double walled with leak detection a Reduced Pressure Backflow Assembly pursuant to Washington State Health Department regulations shall be installed to isolate the fixture.
