Not sure if this is helpful, but the underlying survey sheet has the following figures along the perimeter property lines:

N Line: S 88(degree symbol)22'47" E W Line: S 01(degree symbol)07'02" W

S Line: same as N line

E Line: same as W line, except ends in 07" W

Hi Pete,

I took another look at the site plan for the above referenced application.

The plan contains a note stating "Onsite topography and existing conditions based on AGO Land Survey LLC drawing dated 11/8/17...". A closer look at the plan shows that it's underlain by (presumably) that survey, which does have specific property line measurements called out (the underlay is very light and doesn't show up well on the scanned image).

The survey measurement points don't start and stop at the exact same points as yours, but they do confirm the 1' = 20' scale was utilized. (For example, the underlying survey drawing shows the *entire* westerly lot line as being 238 feet, the aggregate of three smaller measurements of 65.08', 86.15', and 86.77'.)

I hope this helps. Please let us know if you want to view the site plan in person.

Hello Mr. Wetzel,
In Ellen's absence I did some quick measurements on the project file site plan in comparison to the figure in your message below.
Based on the specified site plan scale of $1'' = 20'$ , your measurements appear to be correct within $1-3$ feet, depending on exactly where one starts the scale measurement from. The only measurements where I differed by more than a few feet are along the westerly property line: where your figure indicates 120 feet and 130 feet respectively, I measured 125 feet and 137 feet.
With the above caveats, your measurements appear to be fairly accurate based on the specified site plan scale






