We anticipate this notice to be mailed during this week. The notice will clearly state the comment period and deadline to submit written comments. This is the most important comment period as these comments will be included in the report to the Planning Director/Hearing Examiner and have more weight in the event of an appeal. You will have another opportunity to comment at a public meeting with the Planning Commission. This meeting has not been scheduled yet but you can sign up on a listserv if you would like to receive notice of Planning Commission agendas (https://www.bainbridgewa.gov/List.aspx). Follow the link, enter your email address, scroll down the page to the Agenda Center, and select Planning Commission. Another opportunity for public comment will be provided at the public hearing with the Hearing Examiner. This meeting has also not been scheduled yet. The notice sent out during the first week of February will include a tentative
