1. The remainder of the facility is required to be fire sprinkled. Plans shall be submitted to the Building Department for Fire Department.
2. All existing/outstanding fire code violations and/or concerns shall be resolved prior to a certificate of occupancy being issued.
3. A Certificate of Occupancy inspection by the Fire Department is required for this tenant finish. 48 hour notice is required.
4. Project shall comply with all applicable requirements of the 2006 International Fire Code, related City Ordinances, and Fire Department requirements.
