Thanks for meeting me on site yesterday so I could get more familiar with the property. Yesterday we discussed parking and I saw that you would have 3 spaces in front of the dog training facility/green building (2 ADA spaces and 1 standard) and three spaces down below in front of the garage/existing guesthouse (assuming that there is a spot in front of each of the garage doors) for a total of 6 spots. I noticed that the site plan lists that there are a total of 7 parking spots on sight. Where is the other spot located? Is it in the gravel parking lot in front of the gate, off to the left of the garage?
